First-of-its-Kind "Retirement Credential Survey" Announced

PITTSBURGH, PA, February 7, 2007 -- Credential sponsor Financial Service Standards, LLC (FSS) invites retirement advisors and plan sponsors to participate in a short "Retirement Credential Survey" that will culminate in the "2007 Retirement Credential Comparison Chart."

Better credentialing will help retirement advisors to better meet their responsibilities. This survey will help credential sponsors know what retirement advisors want, and how to provide it."
